SECTION 21 of the Firearms Act 1968

DECLARATION

It is an offence for a person who is prohibited by section 21 of the firearms act 1968 to have a firearm or ammunition in his/her possession at any time.

This section applies to any person who has been sentenced to imprisonment, youth custody or detention in any young offenders' institution for 3 months or more.

A person sentenced to a period between 3 months and 3 years is prohibited for 5 years from date of release.

A person sentenced to 3 years or more is prohibited for life.

It is an offence for a person to transfer, let, hire or lend a firearm to someone whom he/she knows or has reasonable grounds for believing to be a prohibited person.

I hereby declare that I am not a person prohibited by virtue of section 21 of the firearms act 1968.

I also certify that the foregoing information is correct to the best of my knowledge and, if my application is accepted, I agree to abide by the rules and regulations of the club at all times and that during my probationary period I will attend the club regularly to receive instruction in the safe handling and use of firearms.
